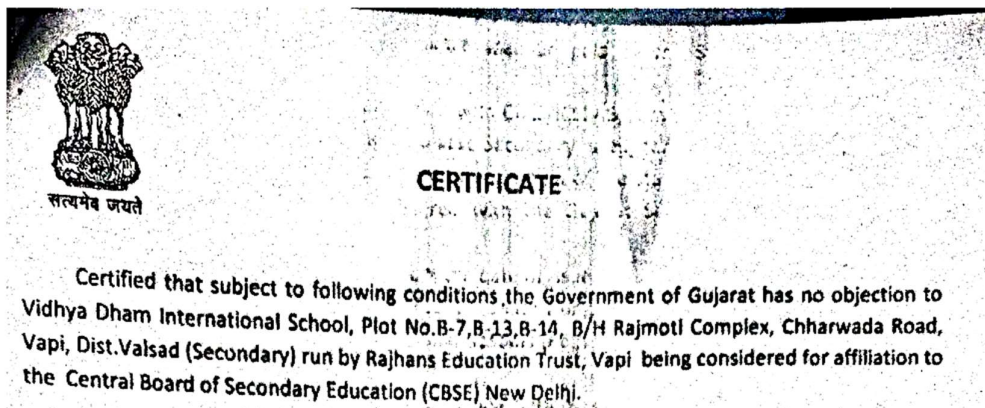


# Copy of the NOC (Class 9 to 12) : Dy. Secretary to the Govt. of Gujarat



## CERTIFICATE

Certified that subject to following conditions the Government of Gujarat has no objection to Vidhya Dham International School, Plot No.B-7,B-13,B-14, B/H Rajmotl Complex, Chharwada Road, Vapi, Dist.Valsad (Secondary) run by Rajhans Education Trust, Vapi being considered for affiliation to the Central Board of Secondary Education (CBSE) New Delhi.

1. The School/Institute shall be open to inspection by the officers of the Education Department or the Officers of the office of the District Education Office duly authorized in this behalf as per relevant Bye laws of the Concerned Board.
2. The School/Institution shall have to obtain necessary permission of the Government of India and other concerned authorities where it is necessary.
3. No grants or any financial assistance shall be paid by the State Government to the School/Institute.
4. As soon as the School gets affiliation with CBSE/ICSE/IB/Cambridge, a copy of the letter of affiliation shall be sent to the Gujarat Secondary & Higher Secondary Education Board, Gandhinagar as well as the Education Department of the State Government and the school shall require to get itself registered with the Gujarat Secondary & Higher Secondary Education Board, Gandhinagar.
5. This NOC is valid for six months from the date of issue.
6. The School/Institution shall produce an undertaking to the effect that it shall follow the provisions of the Gujarat Self-financed Schools (Regulation of Fees) Act, 2017 and the rules made there under.
7. The School shall upload their data to U-DISE System (Unified District Information System for Education) regularly.
8. In case of any breach or contravention of any of the provisions of the Affiliation Bye laws of the respective Board or any provisions of the Gujarat Self-financed Schools (Regulation of Fees) Act-2017, and the rules made there under or any of the conditions of the NOC, State Government reserves its right to withdraw the NOC.



1. The proposed school shall not admit students studying in primary/secondary School of state Government or the school grant in aid.
2. Admissions to the proposed school shall in no way Effect directly or indirectly to the above mentioned school. If the school will be closed or will be running in less than the entire Administrate and Financial Liabilities or any other liability shall be that of the trust and the Government will not be liable in any way.
3. The benefits given to the employees to the grant-in-aid school of Government of Gujarat will not be made available by the state Government to the employees of proposed school or in other words state Government shall not bear any liability in respect of the proposed school.
4. The proposed school shall not use the premises including staff, play ground or any moveable or immovable property of any other school registered under the respective Act of state Government.
5. The state Government will not bear any financial or administrative responsibility of the proposed school. The state Government will not be responsible. If the school/ institution breached of any rules/norms or regulations laid down by above said board.
6. The institution shall have to obtain necessary permission of Government of India and other concerned authorities where it is necessary
7. The school shall appoint only qualified and eligible staff as per qualification laid down in R.T.E. Act-2009/ R.T.E. Rules.
8. The School and its records shall be opened for inspection by an officer/official of the Board or an authorized representative of the Board /State Education department at any time and the School shall furnish information as may be asked for by Board/ State Government
9. The School shall charge the tuition fee and other fee from students as per rules declared by State Government from time to time
